**Subject: Correction in particulars of the Online Application Form for UGC - NET June 2024.**

The NTA has been entrusted by the University Grants Commission (UGC) with the task of conducting UGC-NET, which is a test to determine the eligibility of Indian nationals for (i) 'award of Junior Research Fellowship and appointment as Assistant Professor', (ii) 'appointment as Assistant Professor and admission to Ph.D.' and (iii) 'admission to Ph.D. only' in Indian universities and colleges.

As per the information published in Information Bulletin and Public Notice, it has been decided to provide an opportunity to make corrections in the particulars of their respective Application Forms of UGC - NET June 2024 as per the following details:

The candidates are allowed to make the corrections, **latest by 23<sup>rd</sup> May 2024** (Up to 11:59 P.M.). Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through **Credit/Debit Card/Net Banking or UPI**.

Since, it is a one-time facility extended to the candidates to avoid any hardship to them, the candidates are informed to do the correction carefully, as no further chance for correction will be given to the candidates.
