The NTA has been entrusted by the University Grants Commission (UGC) with the task of conducting UGC-NET, which is a test to determine the eligibility of Indian nationals for (i) 'award of Junior Research Fellowship and appointment as Assistant Professor', (ii) 'appointment as Assistant Professor and admission to Ph.D.' and (iii) 'admission to Ph.D. only' in Indian universities and colleges.

Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through **Credit/Debit Card/Net Banking or UPI.**

Since, it is a one-time facility extended to the candidates to avoid any hardship to them, the candidates are informed to do the correction carefully, as no further chance for correction will be given to the candidates.
