1. The National Testing Agency conducted UGC – NET December 2024 Examination for 85 subjects in Computer Based Test (CBT) Mode at various cities across the country. The Provisional Answer Key(s) for UGC – NET December 2024 Examination conducted on 03rd, 06th, 07th, 08th, 09th, 10th, 16th, 21st & 27th January 2025 along with the Question Paper with Recorded Responses are available on the website https://ugcnet.nta.ac.in/ for candidates to challenge the provisional answer key. The procedure for the challenge of Answer Key is as enclosed as Annexure – I.

2. The candidates, who are not satisfied with the Answer Key, may challenge the same by paying a fee of ₹200/- (Rupees Two Hundred only) per question challenged as a non-refundable processing fee.

- 5. Challenges made by the candidates will be verified by the panel of subject experts. If the challenge of any candidate is found correct, the Answer Key will be revised and applied in the response of all the candidates accordingly. Based on the revised Final Answer Key, the result will be prepared and declared. No individual candidate will be informed about the acceptance/non-acceptance of his/her challenge.
