Subject: Display of Provisional Answer Key(s) and Question Paper with Recorded Responses for inviting Challenges to the Provisional Answer Key(s) of UGC -NET June 2025 Examination.

The National Testing Agency conducted UGC - NET June 2025 Examination for 85 subjects in Computer Based Test (CBT) Mode at different Cities across the country. The Provisional Answer Key(s) for UGC - NET June 2025 Examination conducted from 25th June 2025 to 29th June 2025 along with the Question Paper with Recorded Responses are available on the website https://ugcnet.nta.ac.in/ for candidates to challenge. The procedure for the challenge of Answer Key is as enclosed as Annexure - I.

The candidates, who are not satisfied with the Answer Key, may challenge the same by paying a fee of ₹200/- (Rupees Two Hundred only) per question challenged as a nonrefundable processing fee. The details for Answer Key Challenge are given below:

The payment of the processing fee may be made through (through Credit Card/ Debit Card/Net Banking/UPI Payment Modes till 08th July 2025 (upto 05:00 p.m.). No challenge will be entertained without receipt of the processing fee. The Challenges will not be accepted through any other mode.

Challenges made by the candidates will be verified by the panel of subject experts. If the challenge of any candidate is found correct, the Answer Key will be revised and applied in the response of all the candidates accordingly. Based on the revised Final Answer Key, the result will be prepared and declared. No individual candidate will be informed about the acceptance/non-acceptance of his/her challenge. 

Procedure for Challenge of Answer Key(s) of UGC - NET June 2025 Examination

- 1. Please go to NTA website <u>https://ugcnet.nta.ac.in</u>.
- 2. Click 'Challenge (s) regarding Answer Key'
- 3. Login with **your Application Number and Date of Birth** and enter **the security pin** as displayed and submit.
- 4. Click on "**View Answer Sheet**" for marked responses and to view or challenge the Answer keys, click on the link **Click "Challenge**" button to view provisional answer keys and challenge the questions.
- 5. You will see Question IDs in sequential order, candidates are advised to see your question as per Question ID.



- 6. The ID next to the question under the column '**Correct Option(s)**' stands for the correct Answer Key to be used by NTA. The Dropped Questions are highlighted and not for challenge.
- 7. If you wish to challenge this option, you may use any one or more of the Option IDs given in the next four columns by clicking the check box.
- 8. You may upload supporting documents in which you can select 'Choose File' and upload (all documents to be put in a single pdf file).
- 9. After clicking your desired option, scroll down, '**Submit and review Claims'** and move to the next screen.
- 10. You will see a display of all the Option IDs you have challenged.
- 11. Click on 'Modify your Claims' in case you wish to modify the claims OR 'Final Submit'.
- 12. After saving the claims, you will find a screen displaying your Challenges.
- 13. Kindly pay the fee by clicking on '**Pay Now'**. The claims will be saved finally after successful payment of requisite fee.
- 14. Select mode of payment and pay your fee @ Rs.200/- for each question challenged. Make payment through Debit/Credit Card/Net Banking/UPI.
